5. Guidance

Percentage weight of agricultural commodities in the final product

State the final product's percentage content of agricultural commodities that are subject to tariffs.

- Footnote 1: Declare the percentage of fat in the agricultural commodity.
- Footnote 2: Declare the agricultural commodity.

 Footnote 3: Declare milk fat and milk protein only if the final product contains other dairy products that do not appear elsewhere in the application scheme.
- Footnote 4: Dried agricultural commodities are calculated into fresh agricultural commodities as following: percentage of dried meat/berries/ potatoes x 4 = fresh commodity
